Mayor Cost called the Work Session to order at 5:30 p.m.

Council Member Goldsmith complimented Officer Wilder for the great job he is doing as our Code Enforcement officer.

Fire Chief Brad Davis informed the Council they responded to a total of 35 calls so far this month – 21 EMS and 3 fire calls.

Council Member Herbert informed everyone that the Arbor & Beautification Board will meet December 17<sup>th</sup> at 5 p.m. at Parnell Memorial Library. There will be a ValloCycle Glow Ride on Wednesday at 5:30. The new biker racks will be installed in front of UMOM on December 20-21.

Kirk Hamby, Director of Public Works, said it has been business as usual in his department.

Council Member Herbert reminded everyone there will be a UM sustainability reception tonight at UMOM from 6:30 – 8:30 p.m. He also mentioned there will be a city Sustainability Committee meeting tomorrow at 3:30 p.m. here at City Hall.

Shane Baugh, Director of Parks & Recreation, said basketball season is underway. They have five games being played in town this weekend. Travel Ball has booked our fields every weekend from February to July. The last section of the new trails at Shoal Creek Park has been cut and is being cleaned up.

Dwight Dellinger reported that play at the Golf Course has increased 31% in November versus this time last year. Rounds played year-to-date is up 8%. They recently signed up one new member and 27 members have renewed. He said they are talking to nearby school systems about using our course for their golf teams and tournaments. Several have signed up already. There won't be much activity at the course in the next few days due to the expected rain.

In response to a question from Council Member Nix, Mr. Dellinger explained that we will not be over-seeding the greens this year – we will “paint” them. Our new greenskeeper has explained that over-seeding with rye every year isn't a good idea. The Bermuda grass needs a chance to take hold and rest. We expect our greens will look better than even next spring.

Mr. Dellinger also said he is working on some fun ways to use the course. For example, more midnight golf events, outdoor movies, concerts, etc. The goal is to get more people coming to the course for a variety of reasons.

Council Member Nix said there will not be a Planning Commission meeting in December.

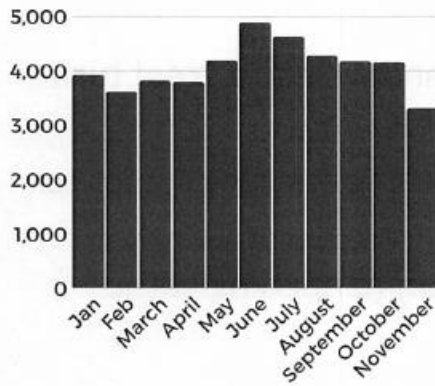

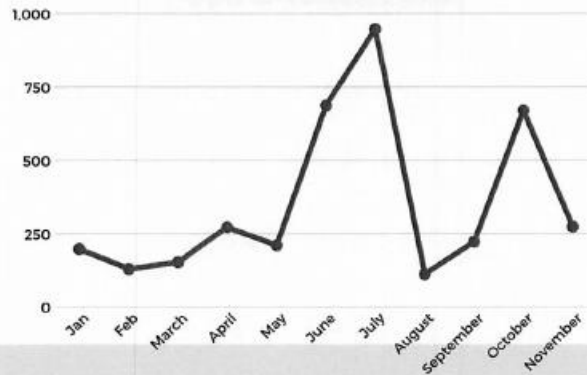



Even though Hwy 25 is not in the Main Street district, the Design Committee has been working on this plan as a means of helping the city. Funds for this would not come from Main Street itself. Dixie said we can order now to get the discounted rate and pay the invoice in October, if we'd like.

Council Member Herbert asked if there are any decorations on Hwy 25 now. Ms. Bennett explained there are not.

Ms. Bennett also informed the Council that our Main Street organization, in conjunction with Mayor Cost, and Cristin Brawner of the Mathews Center for Civic Life, has been selected to present a program at the national 2020 Main Street NOW Conference in Dallas this coming May. She said this is a really big deal for our organization and our community.

Council Member Peterson informed the Council that the MDCD met that afternoon and went over their annual audit. The audit will be available on our website. He said they also discussed the Hwy 25 crosswalk project. That project may be completed by August.

Brenda Baker addressed the City Council regarding her request to deannex her property. She went over the issues as she detailed in her letter:



City of Montwallo,

I, Brenda Baker, request that my property on Reynolds Cemetery Road be de-annexed from the city to Shelby County. I wish to move a double wide mobile home onto this property. My son & daughter-in-law live across the street from where I want to put my home. My health is not good, I've been having dizzy spells and throwing up. I, also, am having shots put in my eyes. My retina specialist tells me I may go blind, even though I am keeping my diabetes in check. We have no garbage pick-up or repairs to our road, which is almost impassable. I hope you will give me consideration and de-annex me back into Shelby county.

Mayor Cost noted that the City Council typically does not agree to deannex property.

The City Clerk said that is true and that under normal circumstances he would not recommend a deannexation. However, he explained that this situation is unique. This property is located at the end of an unpaved county road. No other properties along that roads are in the city limits. The property is at the outer edge of the city limits. Deannexing

this property would not adversely impact our ability to expand our city limits should we desire to do so in the future. As a result, the City Clerk recommended the Council approve the deannexation.

With regard to the request to approve the contract with Skipper Engineering for the Pineview traffic calming plan, the City Clerk explained that the plan would cost us \$3,500 and could be used as a test case for similar traffic calming plans in the future, He said he suggested we do this rather than attempt to create a city-wide policy.

Hwy 25 Christmas Decorations for 2020 – If we order from Dixie in January, we get a 25% discount. 20 lighted snowflakes at \$686/ea. Plus 20 brackets/straps at \$80 each. TOTAL - \$15,320.

Mayor Cost said we need to show some love to the businesses along Hwy 25. Council Member Bunt agreed. The Mayor said she appreciates the fact that, as Ms. Bennett detailed earlier, Dixie is willing to wait for payment until the next budget year. She suggested the Council take them up on that offer and include this expenditure in next year's budget.

Ms. Bennett noted these decorations should last us at least 5 years, especially since we will be able to properly store them in the basement of Victory.

Council Member Herbert asked if we received quotes from anyone else.

Ms. Bennett said there are other companies out there which make these decorations. However, Dixie is located within our city limits. In addition, they are giving us a 25% discount off 2016 prices. Not to mention the fact they are willing to wait on payment until October.

Susan Fuqua, our court consultant, addressed the Council regarding the vacancy in the Municipal Judge position. She strongly recommended the City Council approve our acting judge, Victor Portella, as our permanent replacement for Judge Green. She said she is confident he will do a great job for us.

Mayor Cost thanked Ms. Fuqua for everything she has done to help improve our court.

Ms. Fuqua said it has been a pleasure.

**PROCLAMATION HONORING AMERICAN VILLAGE IN

**Whereas**, Tom Walker envisioned a place to engage young people in the stories of liberty – as a foundation for their becoming good citizens and leaders; and

**Whereas**, in 1993, Mr. Walker began publicly speaking and advocating for the creation of such a place. working with citizens and officials; and

**Whereas**, in 1995 the Citizenship Trust was officially chartered by legislative act sponsored by the late Rep. Al Knight and then Sen. Frank C. Ellis, Jr. as a 501(c)(3) non-profit educational institution; and

**New Business:**

Council Member Goldsmith made a motion to suspend the rules and leave the regular order of business to consider an ordinance to deannex property from the city limits of Montevillo. Council Member Bunt seconded. Mayor Cost, Council Member Nix, Council Member Herbert, Council Member Goldsmith, Council Member Peterson and Council Member Bunt voted AYE . . . MOTION APPROVED.

Council Member Herbert made a motion to approve the deannexation of the Baker property; PID 27-6-23-0-000-005.001 (Reynolds Cemetery Rd). Council Member Bunt seconded.

In discussion, Mayor Cost pointed out once again that this is not something the Council normally does. However, this is a special circumstance and would not set as precedent of any sort.

Council Member Bunt said she is sad to see them leave the city, but certainly understands her need to do so.

The Mayor then called for the vote. Mayor Cost, Council Member Herbert, Council Member Goldsmith, Council Member Peterson and Council Member Bunt voted AYE. Council Member Nix voted NAY . . . MOTION APPROVED.

WHEREAS, the following described real property owned by Brenda Baker is currently within the corporate limits of the City of Montevallo, Alabama

A Parcel of land situated in SW 1/4 of Section 23, Township 22 South, Range 3 West, Shelby County, Alabama, and being more particularly described as follows:

I. That the public good requires that the corporate limits of the City of Montevallo, Alabama, be reduced and the boundaries thereof re-established by the deannexation of the following described real property:

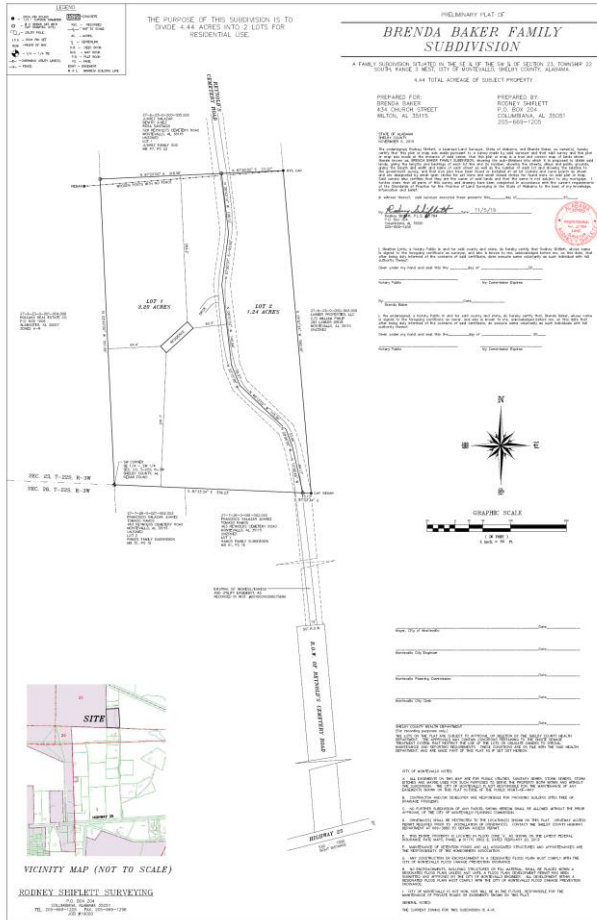

Council Member Nix made a motion to return to the regular order of business. Council Member Herbert seconded. Mayor Cost, Council Member Nix, Council Member Herbert, Council Member Goldsmith, Council Member Peterson and Council Member Bunt voted AYE . . . MOTION APPROVED.

Approval to Contract with Skipper Engineering for Pineview Traffic Calming Plan –

Council Member Nix noted this will be for Pineview only. Mayor Cost said we can use our experience here as a model for future actions.

Council Member Nix made a motion to authorize the Mayor to enter into an agreement with Skipper Engineering for a Pineview Traffic Calming Plan at the cost of \$3,500. Council Member Herbert seconded. ALL AYES . . . MOTION APPROVED.

Creation of City-wide Traffic Calming Policy – Mayor Cost said we will hold off on this for now.

Hwy 25 Christmas Decorations for 2020 –

Council Member Bunt suggested we go ahead and pay for this now using our ending balance / savings from the last fiscal year. Council Member Nix said he preferred adding it to next year's budget. Council Member Herbert agreed.

Council Member Nix made a motion to approve the purchase of the snowflakes as described earlier, paying for them in October out of next year's budget. Council Member Herbert seconded. ALL AYES . . . MOTION APPROVED.

**Old Business:**

Elected Official Compensation Proposal –

Council Member Herbert asked if the Council can require the Mayor to be fulltime. The City Clerk said he investigated that question and the Council cannot.

Council Member Herbert said he looked at the rates the mayor and council are paid in other cities and broke that down to a dollar amount per capita. Based on his analysis, the mayor should be paid \$16,764 per year and the council \$3,498.

Mayor Cost pointed out that these discussions are about what the next mayor and council may be paid, not the current mayor and council.

Council Member Bunt said she feels the council should remain unpaid as long as we have a majority volunteer fire department.

Council Member Nix said two of our neighboring communities that are about our same size pay their mayor \$24,000 and \$41,000 respectively. He said he feels we need to pay the mayor more than the \$15,000 proposed in the resolution. As far as the council goes, he agrees with Council Member Bunt.

Council Member Peterson made a motion to pay the mayor \$24,000 per year. Council Member Goldsmith seconded. Mayor Cost, Council Member Nix, Council Member Goldsmith, Council Member Peterson and Council Member Bunt voted AYE. Council Member Herbert voted NAY. Because this is an ordinance, this is considered the first reading.

**CITY OF MONTEVALLO ORDINANCE ESTABLISHING THE MONTHLY SALARY OF THE MAYOR AND COUNCILMEMBERS**

AN ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA AS FOLLOWS:

**Section 1.** That the salary of the mayor of the City of Montevallo, Alabama, shall be and the same is hereby fixed at the sum of \$2,000 per month; \$24,000 per annum.

**Section 2.** This ordinance shall become effective on the first Monday in November 2020 and shall continue in force and effect until repealed by action of the council.

**Section 3.** The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance.
