Montevallo City Council Work Session September 13, 2021 5:30 p.m. at City Hall

Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Member Martha Eisenberg were in attendance. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Rusty Nix.

Work Session Discussion on Public Hearing Summaries; Public Hearing: SP21-002 Montevallo Commons Lot 16 Site Development Plan and Z21-002 Vick Rezoning A-R & M-1 to B-2 items on New Business. Via Zoom, Kristine Goddard, Shelby County Services; Matthew Burgess, City Engineer. See Appendix 1 and Appendix 2.

Discussion on TextMyGov App/ System tabled from last City Council Meeting on August 23, 2021.

Mayor Rusty Nix called to Move into Committee Reports:

Council Member King called on Chief Littleton for the Police Department Report. Chief Littleton reported there were a Total of 93 Cases: 18 Traffic Accidents, 198 Traffic Citations, 24 Total Arrests, and 10 Thefts. Chief Littleton gave the Code Enforcement Report reported this period; 3 overgrown weeds; 2 trash or debris; Inoperable Vehicles 6; Misc. 3; closed cases 4, continued from last period 9; total new cases, 4; total active cases 13; total cases for the year 89. See Appendix 3.

Council Member King called on Chief Davis, Fire Department for the Monthly Report. Chief Davis reported, there were 70 Calls 2nd half of August, 44 EMS Calls, 12 Lift Assists, 2 Structure Fires, 0 Brush Fire, 1 Electrical Fire, 0 Vehicle Fires, 4 Fire Alarms, 4 MVC, 2 Assist Other Agency, 1 Assist Public which totals to 145 for the Month of August. See Appendix 4.

Council Member King reported Planning and Zoning Commission would meet on September 16th at 6 p.m. in Council Chambers and the meeting is open to the public.

Council Member Dukes called on Kirk Hamby, Public Works Department. Kirk reported he is hearing positive comments about the banner program. The brush truck is still in production by Ford. He reported the department is still short-handed due to vacations and sickness.

Council Member Dukes called on Olivia Barone, Sustainability Coordinator. Olivia reported the ADEM Report for 2021 was completed and submitted. ADECA Grant closed out for Library Lights retrofitting. There will be two additional audits on the Library, City Hall, Fire Department and Recycling Center. She reminded everyone Free Dump Day is October 2nd from 7am until 2pm (the same day as the Fire Prevention Parade). Huntsville is interested in having a Sustainability Program like the one we have in the City of Montevallo and advised like MJCC, MDCD, and Montevallo Main Street we are consistently being recognized for our ability to leverage ideas and programs that create a sense of place for residents and create a town full of culture that people want to visit. Council Member Eisenberg made comments to Shane Baugh about the Tinglewood Festival. Shane reported the Festival was a big success. He reported Stephens Park held big tournaments this past weekend and the Park was filled with teams and families. Travel and Youth Football is now underway until November. The 19th annual "Cars by the Creek" had 115 cars on the field this year and he was so busy he missed it.

The 0.89-acre subject property is zoned B-2, General Business District and is located in the Montevallo Commons Commercial Subdivision, south of Highway 25 across from Industrial Park Road at 104 Montevallo Commons Parkway; Parcel Identification No. 58-36-1-02-0-001-078.009. No Public Comments. This has been approved by the Planning and Zoning Commission with conditions. Public Hearing closed at 6:08 p.m. See Appendix 1. (Previously Noted in Work Session)

Z21-002 Vick Rezoning A-R & M-1 to B-2

This is a request from Joan Vick, property owner, for approval of a change in the zone district boundaries from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District for approximately 9.3 acres to market the property for sale under a single commercial zoning district. The property is located at 3560 Highway 25; Parcel Identification Number 58-36-2-04-4-001-013.000. No Public Comments. Public Hearing called to a close at 6:10 p.m. See Appendix 2. (Previously Noted in Work Session)

Approval and/or corrections of the Minutes: 08.09.21 – Motion by Council Member Mitchell, second by Council Member King, All Ayes, Motion passed.

Recognitions / Awards: 2021 Main Street Magic Maker Award Presentation - Courtney Bennett — Recognizing John and Jan McKinnon Main Street Magic Maker, for their volunteerism with Montevallo Main Street and the City of Montevallo.

Mayor Nix was honored to present a Commendation to the University of Montevallo Bass Fishing Team for earning top team in the nation during the 2020-2021 season. Mayor Nix presented the Commendation to the Team and the Coaches. See Appendix 6.

Mayor Nix called on Opportunities for citizens to speak to the Council:

Presentation by Patrick Johnson from The Mission Continues on Veteran based community initiatives for Montevallo. Mr. Johnson gave a PowerPoint presentation about how "The Mission Continues" assists cities all around the nation. He advised there would be no cost to the city and the labor comes from veterans. He asked the Mayor and City Council to consider the program for Montevallo. See Appendix 7.

Junior Mayor Olivia Gilbert of the Montevallo Junior City Council (MJCC) addressed Council regarding having a seat at the City Council Dias/ Desk. She discussed the MJCC's contributions to the City of Montevallo and shared the goals of the MJCC. She reiterated she feels she should have a seat at the desk / Dias with the City Council Members. (Applause).

Teacher Mrs. Lee Pastor, Government/Economics/Sociology/Psychology/SGA at Montevallo High School appealed to Council about MJCC's Impact on the youth of the city. She appealed to let Jr. Mayor sit at Council desk.

Abigail Heuton, University of Montevallo, and former Jr. Mayor spoke of her time serving and sitting with the Council and on allowing this honor to continue.

Luke Milano, MJCC member spoke on allowing this to continue to bring the honor/ tradition of Olivia's time at the Council back to the desk/ Dias.

C.P. Pierson, 1131 Oak Street, Appeal to Mayor Nix to allow the MJCC Jr. Mayor to sit at the Mayor and City Council desk. Please reconsider your position Mr. Mayor.

Kristy Deerman advised Olivia; Jr Mayor should have a seat at the desk with Council.

Dee Simmons – Addressed Mayor and Council to please allow Oliva to have a seat with Council.

Brady Baugh, MJCC since 8th grade this program inspires all of us do strive to be involved.

Rod McPherson Overland Road the last Audit for the City and the finances are in shambles and what have you done or what are you going to do about it? Mayor Nix asked if there was a specific question he would like addressed. One issue Mr. McPherson brought up city employees using credit cards without checks and balances being in place and Mayor Nix advised that issue has been remedied. Mr. McPherson asked more questions regarding the City Audit and City Clerk Steve Gilbert addressed Mr. McPherson in regard to his multiple email requests. Steve stated he has consulted with the City's Auditors on numerous occasions about improprieties and advised if Mr. McPherson would please ask a specific questions and concerns, he would gladly seek the answers. Steve advised the items listed on the City Audit have been addressed such as taking monies for City Sports which is being done at City Hall and he reminded Mr. McPherson there are cameras to watch every transaction. The same applies to the City's credit cards. An employee must sign out and describe what is intended to purchase, sign back in when the credit card and receipt is returned along with employee's signature. If Mr. McPherson would address Mayor, City Council or City Clerk with specific items they would be happy to address each one.

CP Pierson 1131 Oak Street spoke regarding the City Council Audit and confirmed the report the citizen was questioning was done for the previous administration. City Clerk Steve Gilbert advised yes the audit documents given Mr. McPherson were for the 2019 – 2021 Fiscal Year. The 2020 – 2021 Audit is being prepared at this time and will be presented to the Council in October.

Greg Reese 1 Brookwood Drive Please allow MJCC Jr Mayor to have a seat with Council. He then passed out a document to the Mayor and Councilmembers: "State of Alabama; Shelby County Legislative Delegation, Shelby County, Alabama RESOLUTION. See Appendix 14.

Mayor Requested Committee Reports be Continued:

Mayor Nix called on Council Member Mitchell for reports on Education, Arts, and Outreach. Council Member Mitchell called on Sarah Hogan, Executive Director, Impact Montevallo. Sarah reported IMPACT will be at the home MHS football game Friday night and passing out fans to the public to promote IMPACT programs. IMPACT will be at each home game on Friday night's so if anyone is interested in volunteering let her know. Sarah reported there is a Community Survey that will be released on social media and in the Chamber Chatter and to please look for it and would like everyone's input. She advised that IMPACT will be holding interviews beginning tomorrow for the Youth Coordinator position. Sarah reported Red Ribbon and National Night out will be in October and IMPACT is planning events now for the week-long activities. The theme this year is Drug Free Looks Like Me! They are kicking off with the National Prescription Take-Back Day, partnering with National Night Out, continuing the Chief's Challenge, Senior Night, and Hometown Halloween. She asked Mayor and Council to join them for an Action Team Meeting and also reminded Mayor and Council MJCC is open to them and to the citizens. See Appendix 8.

Council Member Mitchell reported September is Montevallo High School Attendance Awareness Month. Montevallo High School will play football at home Friday night. She reported the American Village is offering walking tours through the month of August and September, 10 a.m. – 4 p.m. Admission is free. Council Member Mitchell reported the American Village is now booking field trips 2021-2022 for grades 4th-12th beginning October 1. The 2021 Art Walk will be October 23rd 11 a.m. – 6:00 p.m.

Council Member Mitchell gave the report for Savannah Kitchens, Library Director. She reported Storytime with Mr. Mac, Mini Music, Dial-A-Story, a Senior Movie, and Board Games and literacy kits (19 total) Programs and Services for the community. There were 17,760 items checked out of the library, Montevallo saved \$298,462.20 by using the library. There were 1,399 visits to the building, 98 program participants, 109 phone calls, and 1,063 Wi-Fi and computer sessions. Genealogy class with the Alabama Department of Archives and History is on September 14th at 6:30 p.m. and The week of September 13-17 kids can grab a S'mores Pops take home baking kit. See Appendix 9.

Mayor Nix called on Council Member Swords for reports on Finance, Economic Development & Tourism. Council Member Swords called on Adele Nelson, Executive Director, Montevallo Chamber of Commerce. Adele reported there were 5,000+ people that attended Tinglewood Festival this year. She reported the Chamber Luncheon is this Wednesday, and the new Montevallo Area Map is on track to be printed this month. Soul Spot will hold its ribbon cutting on 9/18/21 at 1 pm. She reported the 2021 Shelby County Tourism and Recreation ALL Star Awards Luncheon will be on October 7 at Old Mill Square, Columbiana. See Appendix 10.

Council Member Swords reported Finance Committee will meet 9/22 at 5:30 p.m. and MDCD will meet 9/20 at 1 p.m.

Public Health & Safety (Police, Fire, Code Enforcement, Housing Abatement, Planning and Zoning) – reported during work session.

Sustainability (Streets & Sanitation, Recycling, Arbor & Beautification, ValloCycle, Environmental Preservation Initiatives, and Historical Commission) – reported during work session.

Recreation, Preservation and Community Development (Parks & Recreation, Youth Athletics, Trails, Annexations) – reported during work session.

Education, Arts & Outreach (Schools, Library UM, Boys & Girls Club, American Village, Sister City Commission, Artwalk, IMPACT) – Parnell Memorial Library, IMPACT, American Village, UM, and the Boys & Girls Club – reported during regular City Council Meeting.

SP21-002 Montevallo Commons Lot 16 Site Development Plan

Note: On August 19, 2021 the Montevallo Planning and Zoning Commission reviewed and recommended conditional approval of the site plan.

This is a request from Scott Lovelady, on behalf of Montevallo Commons LLC, for the approval of a site development plan for a general commercial building. The 0.89-acre subject property is zoned B-2, General Business District and is located in the Montevallo Commons Commercial Subdivision, south of Highway 25 across from Industrial Park Road at 104 Montevallo Commons Parkway; Parcel Identification No. 58-36-1-02-0-001-078.009.

Property Summary

The subject property contains 0.89 acres and is identified as Lot 16 in the Montevallo Commons Commercial Subdivision. The applicant proposes to construct a 3,200 square foot building shell for commercial use. Based on the total disturbed area of this development the City Engineer has determined that a land disturbance permit is not required for this project.

The applicant has indicated the proposed 3,200 square foot structure will be a "spec building". Approximately 950 square feet may be used as office space and the remaining 2,250 square feet may be used as warehousing space. The proposed designated uses of the spec building require nine parking spaces. The site development plan identifies 14 parking spaces including one ADA designated space. The provided parking is compliant with Article 22. Off Street Parking and Loading Requirements.

The applicant has included frontage, foundation and perimeter landscaping as identified in Article 23.03.C. of the *Montevallo Zoning Ordinance*. The Arbor and Beautification Board has reviewed the landscape plan and determined it to be in substantial compliance with the landscape regulations. The Landscape Plan was prepared by the applicant's Engineer. Article 23 of the *Montevallo Zoning Ordinance* requires landscape plans to be stamped by a Landscape Architect. A landscaping bond in the amount of 125% of the value of materials and cost of installation of the landscaping to be installed must be posted prior to the release of a building permit. The requirement to post the bond should be included as a condition of any site plan approval.

Planning & Zoning Recomendation

On August 19, 2021 the Montevallo Planning & Zoning Commission held a public hearing and discussion for the proposed site plan. No one present spoke in favor or opposition of the request. At the time of the meeting all outstanding items addressed in the staff report had been completed with the exception of the landcape plan being prepared/reviewed and stamped by a Landscape Architect registered in the State of Alabama. The Planning and Zoning Commission reviewed the requirements of for a landscape plan and included with their recommendation to Council that the applicant should adhere to Article 23 in the Zoning Regulations pertaining to the preparation/review and stamping of landscape plan by a Landscape Architect registered in the State of Alabama.

SUMMARY

The proposed development is substantially in compliance with the Zoning Ordinance of the City of Montevallo. An approval by the City Council should be subject to:

- Compliance with the regulations, policies and guidelines of the City of Montevallo;
- The applicant submit all required bonds and a final site plan for certification prior to the issuance of building permits.



Case No. SP21-002 Montevallo Commons Lot 16 Site Development Plan

This is a request from Scott Lovelady, on behalf of Montevallo Commons LLC, for the approval of a site development plan for a general commercial building. The 0.89-acre subject property is zoned B-2 and is located in the Montevallo Commons Commercial Subdivision, south of Highway 25 across from Industrial Park Road at 104 Montevallo Commons Parkway; Parcel Identification No. 58-36-1-02-0-001-078.009.

DISCUSSION

The subject property is located in the Montevallo Commons Commercial Subdivision, south of State Route 25. Montevallo Commons Parkway is located approximately 500 feet west of Industrial Park Road. Montevallo Commons is a commercial subdivision development, recorded in 2008 in Map Book 39, Page 142 (*shown below*) and was designed as a private commercial subdivision with private septic systems on each lot and a common detention pond for Stormwater. The subject property is zoned B-2, General Business District according to the *Zoning Ordinance of the City of Montevallo* and is not located in any overlay districts.



Proposed Site Development

The subject property contains 0.84 acres and is identified as Lot 16 in the Montevallo Commons Commercial Subdivision. The applicant proposes to construct a 3,200 square foot building shell for commercial use. Based on the total disturbed area of this development the City Engineer has determined that a land disturbance permit is not required for this project.

Access

Montevallo Commons accesses Hwy 25 via Montevallo Commons Parkway (a private drive). The proposed development on Lot 16 identifies one ingress/egress location along Montevallo Commons Parkway.


Parking

The applicant has indicated the proposed 3,200 square foot structure will be a "spec building". Approximately 950 square feet may be proposed as office space and the remaining 2,250 square feet may be proposed as warehousing space. Without a specific use or specific tenant/occupant identified, the following parking and loading requirements were utilized to ensure adequate parking spaces and loading areas are provided. According to Article 22. Off Street Parking and Loading Requirements of the *Montevallo Zoning Ordinance*, a Business/Professional Office use must provide three parking spaces, plus one space for every 300 square feet of floor area over 1,000 square feet in a proposed building. A Warehousing use requires one parking space per company vehicle plus one parking space per employee.

The proposed office space of 950 square feet requires three parking spaces. The applicant has provided an estimate of three employees, each with a company vehicle in addition to a personal vehicle, requiring six parking spaces. The proposed designated uses of the spec building require nine parking spaces. The proposed site development plan identifies 14 parking spaces including one ADA designated space. The provided parking is compliant with Article 22. Off Street Parking and Loading Requirements.

Landscaping

The applicant has included frontage, foundation and perimeter landscaping as identified in Article 23.03.C. of the *Montevallo Zoning Ordinance*. The Arbor and Beautification Board has reviewed the landscape plan and have found it in compliance with the landscape regulations. A landscaping bond in the amount of 125% of the value of materials and cost of installation of the landscaping to be installed must be posted prior to the release of a building permit. The requirement to post the bond should be included as a condition of any site plan approval.



Utilities

Montevallo Water Works and Sewer Board has completed a review of the plan set dated 7-09-2021. The review was completed in regards to potable water and sanitary sewer only. At the time of this report the following items are still outstanding.

- 1. General Comments Sheets 8 and 11
 - a. A benchmark shall be **located and shown** on each sheet.
 - b. Montevallo Water and Sewer Board representative shall be present when any work is performed on the water system.
 - c. Water Services shall be Cross-linked Polyethylene ("PEX") pipe meeting the requirements of AWWA C904.
 - d. A Developer Water Agreement must be submitted.
 - e. Provide all pertinent Montevallo Water and Sewer Board details. Details can be found in the Montevallo Water and Sewer Board standard potable water specifications.
 - f. Provide documentation from the governing body that the septic system has been approved.

Prior to City Council review and consideration these items must be corrected; however the modifications identified do not alter the layout or design of the submitted project and the Planning and Zoning Commission could include the items as a conditional recommendation to be completed administratively and reviewed prior to City Council action. The applicant has submitted revised plans that were in review at the time of this report.

Storm Water

The City Engineer has completed a review of the plan set dated 7-09-2021. At the time of this report the following items were still outstanding.

- 1. A detail for the stormwater flume should be added to the plan set.
- 2. Embankment slopes must be indicated on the grading plan.
- 3. A side drain pipe may be required in the graded ditch along Montevallo Commons Parkway to prevent ponding of water at the driveway.
- 4. Wattles must be part of the BMP plan for all existing and proposed ditches.


Prior to City Council review and consideration these items must be corrected; however the modifications identified do not alter the layout or design of the submitted project and the Planning and Zoning Commission could include the items as a conditional recommendation to be completed administratively and reviewed prior to City Council action. The applicant has submitted revised plans that were in review at the time of this report.

Summary

The proposed development is substantially in compliance with the Zoning Ordinance of the City of Montevallo. Several remaining items must be addressed and corrected prior to final consideration of the City Council. The remaining items do not alter the design of the project as it has been presented to the Planning and Zoning Commission and should be corrected prior to consideration by the City Council. A recommendation to the City Council should be subject to:

- The applicant submitting a revised site plan addressing all remaining corrections to be reviewed administratively prior to consideration by the City Council;
- The applicant completing all required bonding and submitting a final site plan for certification prior to the issuance of building permits;

- Compliance with the regulations, policies and guidelines of the City of Montevallo;
- Approval by the Montevallo City Council.












Note: On August 19, 2021 the Montevallo Planning and Zoning Commission reviewed and recommended approval of the rezoning request.

This is a request from Joan Vick, property owner, for approval of a change in the zone district boundaries from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District for approximately 9.3 acres to market the property for sale under a single commercial zoning district. The property is located at 3560 Highway 25; Parcel Identification Number 58-36-2-04-4-001-013.000.

Property Summary

Ms. Vick owns four parcels of land in the surrounding area with one parcel, located in the town limits of Wilton, containing a mobile home park. Two parcels, owned by the applicant, are located north of the subject property and zoned B-2 General Business District in the City of Montevallo. The subject property is a single 9.3 acre parcel with two zoning designations: A-R, Agricultural-Residential District (8 acres) and M-1, Light Industrial District (1.3 acres).



The applicant has not proposed any site modifications with the request to change the zoning district. There is no proposed use of the property; however, Ms. Vick indicated that the existing home could be transitioned into an office use or redeveloped into another approved use in the B-2 district.

A site concept plan for the subject property was presented with the application including a development option and reconfiguration of the four parcels of land owned by the applicant. The presented concept plan would require a resubdivision and is not tied to this zoning request.

The City of Montevallo Comprehensive Plan, *Making Montevallo*, designates the subject

property as "Industrial." The Industrial land-use category serves a critical role in providing jobs and tax-base to the city. Typically, industrial uses are located away from residential areas as sound, freight traffic, and bright lighting can be incompatible with neighborhoods. The single-family residence located on the subject property is surrounded by commercial and industrial uses in the Highway 25 corridor.

The location of this parcel at the shared municipal boundary with the Town of Wilton also creates a transition from the Commerical Hwy 25 corridor in Montevallo to the the residential properties located in Wilton.

Planning & Zoning Recomendation

On August 19, 2021 the Montevallo Planning & Zoning Commission held a public hearing and discussion for consideration of the request of Ms. Vick. No one present spoke in favor or opposition of the request to rezone the property to B-2 General Business District. The Planning & Zoning Commission unanimously recommended approval of the rezoning request from a change in the zone district boundaries from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District for the approximately 9.3 acres.

SUMMARY

The applicant proposes rezoning the subject property from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District to market the property for sale under a single commercial zoning district. As proposed, the change in zoning district is likely to have minimal impact to the character of the surrounding area.



This is a request from Joan Vick, property owner, for approval of a change in the zone district boundaries from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District for approximately 9.3 acres to market the property for sale under a single commercial zoning district. The property is located at 3560 Highway 25; Parcel Identification Number 58-36-2-04-4-001-013.000.

Site Description

The subject property is located at 3560 Highway 25 and just north of the town limits of Wilton. Properties to the south of the subject property include a manufactured home park (owned by the applicant), single-family homes and vehicle storage, located in the town of Wilton. Two parcels adjoining the subject property to the north are zoned B-2, General Business District (owned by the applicant). Additional properties zoned B-2 district are located on Highway 25 directly to the north. West of the subject property includes undeveloped land, zoned A-R, Agricultural-Residential District and Summer Classics furniture, zoned M-1 district. East of the subject property is the Montevallo Cemetery on Highway 73, zoned A-R district. Continuing northeast along Highway 25 and Spring Drive are additional commercial and industrial uses zone B-2 district and M-1 district, respectively.



Approximately eight acres of the 9.3 acre subject property is zoned A-R, Agricultural-Residential District and contains a single-family dwelling. The remaining approximately 1.3 acres is zoned M-1, Light Industrial District and contains two warehouse accessory buildings.

Proposed Change in Use

The applicant is requesting to rezone the subject property from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District to market the property for sale.

The applicant states in the justification statement that after retiring in 2006 and moving out of Alabama she continued to rent the home located on the subject property. The applicant indicates that the property has been listed for sale as a residential home on multiple occasions with no purchasers. Further, the applicant notes that in 2017 her husband passed away and the sale of the home will help put personal affairs in order. The applicant is asking to rezone the property to a B-2 use at the advice of a Real Estate agent. A copy of the full justification statement is included at the end of this report.

The applicant has not proposed any site modifications with the request to change the zoning district. The applicant proposes to market the property, as is, under the new zoning classification if approved. At the time of this report no buyer or contract is noted.

Additional Approvals Required

Pursuant to a rezoning approval, development of the property as a commercial business will require an applicant to submit a fully engineered site plan that meets all requirements of the *Montevallo Zoning Ordinance*. Site Plans are reviewed by the Planning and Zoning Commission and the City Council.


The Water Works and Sewer Board, Montevallo Fire Chief and the City Engineer have reviewed the rezoning request and offered no additional comments at this time.

Planning Analysis

The primary purpose of zoning land is to provide for the public health, safety and welfare in the development of land by ensuring that property is developed in an appropriate manner within the context of its immediate surroundings and the larger community of which it is a part. There are times when changes in the zoning of certain property are justified. For example, when a community is experiencing frequent requests for rezoning in a relatively small area, this is an indication that local trends and conditions may have changed, altering the assumptions underlying the existing zoning.

The applicant is proposing a change in use from residential to general business. As proposed, the change in use would have minimal impact to the character of the surrounding area that has developed with commercial (shown in red at right) and industrial uses (shown in purple at right). The existing single-family residence is generally out of character with current commercial and industrial development along Highway 25.

The City of Montevallo Comprehensive Plan, *Making Montevallo*, designates the subject property as "Industrial." The Industrial land-use category serves a critical role in providing jobs and tax-base to the city. Typically, industrial uses are located away from



residential areas as sound, freight traffic, and bright lighting can be incompatible with neighborhoods. The subject property's single-family residence is surrounded by commercial and industrial uses in the Highway 25 corridor.

Making Montevallo further describes industrial areas as being near major roads, highways, and other industrial centers. These areas are often buffered from surrounding development by transitional uses or landscaped areas that shield the view of structures and loading docks. Secondary uses within the industrial district might include professional offices, and supporting commercial uses.

Conclusion

The applicant proposes rezoning the subject property from A-R, Agricultural-Residential District and M-1, Light Industrial District to B-2, General Business District to market the property for sale under a single commercial zoning district. As proposed, the change in zoning district is likely to have minimal impact to the character of the surrounding area.

The City of Montevallo Comprehensive Plan, *Making Montevallo*, identifies that industrial uses are typically located away from residential areas as noise from freight traffic, and bright lighting can be incompatible with area neighborhoods. The subject property is a single-family residence that has experienced commercial and industrial growth in the surrounding area. The subject property, primarily as a single-family residence, is now out of character with the continued expansion of commercial and industrial development in the Highway 25 corridor.

The reclassification of the subject property would allow the transition and redevelopment of the property to become more compatible with the surrounding commercial and industrial uses. Pursuant to a rezoning approval, an applicant will be required to submit a fully engineered site plan that meets all the requirements of the *Montevallo Zoning Ordinance*. Pursuant to a denial of the rezoning request, no action for a zoning amendment may be requested for the same property for a period of twelve (12) months without unanimous approval by the City Council.

ARTICLE 16. B-2, GENERAL BUSINESS DISTRICT

Section 16.01. Generally.

The regulations set forth in this Article or set forth elsewhere in this Ordinance, when referred to in this Article, are the regulations in the B-2, General Business District. This district is intended to provide a zoning classification for general commercial uses.

Section 16.02. Use Regulations.

A. Permitted uses.

Within the B-2, General Business District, only the following uses and structures designed for such uses shall be permitted:

- 1. Any use permitted in the B-1, Local Business District, provided, however, that the limitations upon extent of service area shall not apply.
- 2. Automobiles or trailer display and sales room.
- 3. Public garage.
- 4. Frozen food locker.
- 5. Farm support business.
- 6. Hospital or clinic for animals, but not including open kennels.
- 7. Funeral Home.
- 8. General retail store or shop (enclosed).
- 9. Pawn Shop.
- 10. Fast Food or Drive-In Restaurant.
- 11. Used car lot.
- 12. A shopping center or facility composed of any one or more of the permitted uses or any combination thereof.
- 13. Home Improvement Center.
- 14. Hardware or building materials sales.
- 15. Entertainment and Recreation (Indoor).
- 16. Mini-Storage (not permitted on Main Street).
- 17. Automotive, farm implement or trailer repair or servicing; provided that all work on the premises is done within a building, and all materials are stored in a building.
- 18. Carpentry, painting, plumbing and electrical shops; provided that all work on the premises is done within a building, and all materials are stored in a building.

B. Conditional uses.

Within the B-2, General Business District, the following uses may be allowed as conditional uses:

- 1. Outdoor recreation.
- 2. Public Utility Facility.
- 3. Nursing home.



Dear Shelby County Zoning Committee,

In 1972 we purchased the 12 acre parcel bordering Wilton city limits on Highway 25 and county highway 73. On this property we built our home facing Highway 25 and a small trailer park facing highway 73. We also built mini storage units and a building to be used as a workshop. A few years later we purchased two adjacent parcels that contain a rental house and this parcel was already zoned commercial/industrial. The remaining property adjoins or is fronted by business, industry, and a cemetery. We had the property zoned Montevallo city limits for fire protection.

Since retiring and moving out of state in 2006 we have had to rent our home. We have tried listing the home for sale several times but no one has wanted to buy as a residence because of the location/surrounding property. Since my husband passed away in 2017 I have been attempting to get my estate in order. I have been advised by realtors that I should have the property rezoned business/commercial-that it would be more marketable. Your consideration and assistance would be greatly appreciated.



Throughout this year, thousands of veteran volunteers will lead and support service efforts across the country to commemorate the 20th anniversary of the 9/11 terrorist attacks, recognizing the service and sacrifice of the all-volunteer force that served in the wake of that day. Launched by The Mission Continues, this extended campaign will also kick off the next 20 years of a veteran-led movement of service.

In the two decades since 9/11, veterans have continued to step up and serve their country, creating connections and relationships that have deepened their sense of belonging and purpose through The Mission Continues. And they're just getting started, as veterans are deploying support for more than 80 projects between July and November to communities all across the country. Our national organization has recently established service platoons in the Montgomery & Birmingham areas.

TMC platoon staff respectfully request authorization to initiate this project & to complete it no later than the last day of Phase 3, MLK Day, 2022. Ordinance No. 08232021-329

An Ordinance Establishing Operational Hours of City Parks and Pavilions

Whereas, the City of Montevallo desires, to do everything it can to protect the health and welfare of its citizens while providing the best possible experience in our public parks and facilities; and

Whereas, in the interest of public safety it is necessary to establish dedicated hours of operation of those public areas and facilities.

NOW, THEREFORE, BE IT ORDAINED as follows:

- 1) That all Montevallo City Parks and their Facilities shall be open to the public from sunrise until dusk except as noted:
- 2) The lighted athletic fields and facilities of Stephens Park during sporting events.
- 3) The lighted athletic fields and facilities of Orr Park during sporting events.
- 4) Owl's Cove Park during organized after hours events.

After hours events in any City Park and its facilities not specified by this ordinance requires permission of the City Council. All events must comply with existing City Ordinances regarding Noise and Public gatherings.

Penalties for violation of this ordinance shall be as follows:

a. Any person found guilty of non-compliance or violation of the ordinance set forth in this document shall be fined \$50.00 plus any costs for the first offense; \$100.00 plus any applicable costs for the second offense \$200.00 plus any applicable costs for third offense and may be jailed at the discretion of the municipal judge up to the limits of municipal jurisdiction for fourth and subsequent offenses.
