Montevallo City Council Work Session March 22, 2021 5:30 p.m. at City Hall

Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg, were in attendance. Mayor Rusty Nix absent. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Pro Tem David King.

Chief Littleton presented the Police Department Monthly Report with a total of 605 cases. See 3 pages in Appendix 1.

Chief Davis presented the Fire Department Monthly Report with 34 EMS calls, 4 Life Assists, 2 Structure Fires, 6 Brush Fires, 1 Vehicle Fire, 4 MVC, Assist Other Agency – 0, 1 Fire Alarm for a total of 52. There were 6 Fire Inspections. See Appendix 2.

Councilman Dukes called on Olivia Barone, Sustainability Coordinator. She reported in March there were 13.3 tons of recycling and so are for 2021 there has been 54 tons of recycling. And reminded Council they also take E-recycling anytime. She announced Free Dump Day will be held from 7:30 a.m. until 3:30 p.m. on Saturday, March 27th at the Shelby County Landfill. See Appendix 3.

Councilman Dukes called on Kirk Hamby, Public Works Director to give a report on surplus items to be sold. He reported Pearce & Associates is scheduled to take pictures of items for auction.

Kirk Hamby spoke on behalf of Shane Baugh, Parks and Recreation Director, recommending new mowers stating certain mowers are for ballfields and other mowers for parks. He announced the Easter Egg Hunt will be Saturday, April 3rd at 10:00 a.m.

Councilwoman Mitchell called on Savannah Kitchens, Library Director for the Library Report. She reported Dial-A-Story is free and can be accessed any time and the story changes each month. She reported Hoopla app is launched. See Appendix 4.

Councilwoman Mitchell called on IMPACT Director, Sarah Hogan. Sarah called on Olivia Gilbert, Junior Mayor, Montevallo Junior City Council (MJCC). Olivia reported the MJCC is promoting on social media seeking applications for membership. The MJCC is working on a Spring project and partnering with the High School Ag class and Park & Recreation on a build a Bird House project.

Sarah Hogan, IMPACT Montevallo reported there are several family friendly events scheduled for April in conjunction with Earth Day and is partnering with Olivia Barone, Sustainability. She

reported IMPACT is continuing with the Marijuana Public Awareness Campaign. She thanked the Montevallo Police Department for visiting retailers to make sure they were aware of a substance classification change. And reminded Council to thank those retailers with a Family Friendly Vendor sticker in window. See Appendix 5.





Mayor and Council,

While on a vacation on March 9, I received a number of messages indicating that the Council had conducted a lengthy discussion of the Montevallo Development Cooperative District (MDCD) at its March 8, 2021 regular meeting. I took the time yesterday afternoon to watch the video recording of the Council meeting. Those participating made many incorrect statements and I was offended both by the tone and what felt to be a personal attack on me. I was much more offended by the clear lack of support for an entity that has driven every major capital improvement project in this city for the past decade. MDCD is a perfect example of how working together accomplishes more. The list of city improvements that would never have been completed without MDCD is too lengthy to set out, but walk outside and look around and you'll see many. I would like to make three things clear:

- (1) I have reached out to the Mayor and each council member, repeatedly, regarding all of the operations of MDCD, most recently regarding the funding of the Sims House/Free Community Counseling Center, and have never had the courtesy of a single reply, with the exception of Kenny Dukes about the Sims House;
- (2) Despite my repeated efforts to include and inform the Mayor and Council of the operations of MDCD, no one has reached out to me with questions about the MDCD or had the courtesy to inform me that this issue would be addressed at the March 8 meeting. As someone who has volunteered innumerable hours of my time over the last decade to improvement of this city, and attempted to build and maintain cordial and productive relationships with everyone, I can only say I hope you don't treat future volunteers in this manner;
- (3) As it is clear that I do not have the confidence of the current Mayor and Council to represent the city on MDCD, nor even rate the courtesy of an invitation to discuss something that I have more insight, knowledge, and experience with than anyone on the Council, I hereby resign as the City's designated representative to MDCD, effective immediately.

I wish you all the best as you seek to improve our city. I would respectfully suggest that in the future you not treat other volunteers as you have treated me.





ORDINANCE NO. 03222021-304

AN ORDINANCE ASSENTING TO A CERTAIN PETITION FOR ANNEXATION

Whereas, all of the owners of property located and contained within an area contiguous to the corporate limits of Montevallo, and not within the corporate limits or police jurisdiction of any other municipality, have signed and filed a written petition with the City Clerk requesting that such property or territory be annexed to Montevallo, and

WHEREAS, said petition contains an accurate description of the property or territory proposed to be annexed together with a map of the said territory showing its relationship to the corporate limits of Montevallo,

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA, AS FOLLOWS:

1. That the City Council of the City of Montevallo, as and for its governing body, hereby assents to the annexation of that certain land of approximately 75 acres lying south of the Columbiana – Tuscaloosa Road and to the north boundary of Shelby County Highway No. 22, upon the petition of the Estate of Sherwood J. Stamps by its personal representative, Beverly F. Stamps, the owner, as provided in §11-42-21 of the 1975 Alabama Code and other applicable law.

LEGAL DESCRIPTION:

The E ½ of NE ¼ of Section 2, Township 22, Range 3 West, excepting therefrom 1 ½ acres more or less in the southwest corner of the E ½ of NE ¼ of said Section 2, said excepted portion being all that part lying south of the Columbiana-Tuscaloosa Road. A portion of above-described land is also known as lots 1 to 5, both inclusive, as shown on survey of EDSCO Estates, as recorded in Map Book 4 on page 83 in the Probate Office of Shelby County, Alabama.

LESS AND EXCEPT the following described property:

Part of the East 10.00 feet of the E½ of the NE¼ of Section 2, Township 22 South, Range 3 West and of Lot 5, Ebsco Estates, as recorded in Map Book 4, Page 83 in the Probate Office of Shelby County, Alabama, lying North of Shelby County Highway No.22 described as follows: Commence at the NE corner of the E½ of the NE¼ of Section 2 and go South 00 deg. 55 min. 39 sec. East along the East boundary of said E½ of the NE¼ for 16.00 feet to the Point of Beginning; thence continue along previous course for 2569.43 feet to the North boundary of Shelby County Highway No. 22; thence North 88 deg. 46 min. 38 sec. West along said North boundary for 10.00 feet; thence North 00 deg. 55 min. 39 sec. West for 2559.38 feet; thence North 45 deg. 00 min. 17 sec. East for 13.92 feet to the Point of Beginning.

This ordinance shall become effective upon its passage and advertisement as provided by law.
