#### **MINUTES**

Montevallo City Council Work Session May 24, 2021 5:30 p.m. at City Hall

Mayor Rusty Nix, Council Member David King, Council Member Lelia Mitchell, Council Member Kenneth Dukes, Council Member Sonya Swords, Council Member Martha Eisenberg, were in attendance. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Rusty Nix.

Chief Littleton's Police Department Monthly Report was presented by Lt. Harrelson. He reported there was a total of 396 calls, 64 Total Reports, 130 Traffic Citations, and 24 Total Arrests. Officer Mike Wilder's Report showed a total of 11 cases: 4, Overgrown Grass and Weeds, 1, Trash and/or Debris, 2 Inoperable Vehicles, 3 Unsafe Structures, 3 Miscellaneous; 3 Closed Cases; 7 Continuances; Total Number of Cases for the Year is 53. See Appendix 1.

Chief Davis presented the Fire Department Monthly Report with a total of 66 calls: 40 EMS calls, 7 Lift Assists, 2 Vehicle Fires, 7 Fire Alarm, 2 MVC, 2 Fuel Spills, 1 Assist Other Agency, 3 Assist Public, 2 Assists Water; 13 Fire Inspections, 1 Re-Inspection. See Appendix 2.

Council Member Dukes reported for absent Department Head, Olivia Barone, Sustainability Coordinator. Her report reminded Council about the Weatherization Program in which Gov. Kay Ivey has awarded grants totaling \$3.2 million to assist low-income, elderly, and disabled Alabama residents to lower energy costs and if anyone had questions, they could call the Central Alabama Regional Planning and Development Commission at 334-262-4300 ext. 217. ADEM completed their inspection of the Recycling Center, Submitted ADECA State Energy Program reimbursement for \$34,000: a) This grant was to retrofit lights in the Library to LED, b) kWh saving over 60,000 and cost savings of \$10,000 annually, c) May 2021 usage down 5,000 kWh or \$844 from May 2019. See Appendix 3.

Council Member Dukes advised Public Works Department Head Kirk Hamby absent and had no Streets and Sanitation report.

Council Member Eisenberg called on Shane Baugh, Parks and Recreation Department Head, and he reported Stephens Park restrooms for women, and men did not have the capacity to accommodate 2,000+ people attending youth sports events. All restrooms need updating. He will evaluate to determine if RV pads for parking are feasible as they would only need electrical connections and water. Tournament bookings continue to grow; evaluating trails to be ADA compliant, soccer program continues to grow, and additional fields are needed; creek cleanup project is still ongoing at Shoal Creek and Orr Parks. He reported the Parks and Recreation Department needs more staff to keep up with the demand. Stephens Park needs a PA System, especially for announcements in case of an emergency. Girl Scouts are hoping to raise funds to

add handicapped swings in the parks. Council Member Eisenberg announced Senior Bingo will be held on July 10<sup>th</sup>.

Council Member Mitchell called on Savannah Kitchens, Library Director for the Library Report. Savannah reported the Summer Reading Program kicks off on June 3<sup>rd</sup> and continues thru July 15<sup>th</sup>. Movie Night will be June 3<sup>rd</sup> and is free. Starting June 7<sup>th</sup> each week there will be a new craft kit for youth from preschoolers to high schoolers. A Bird Bingo sheet is available at the Library, this is a self-guided activity for families to get outside and bird watch at Shoal Creek Park. Dial-A-Story will be updated with a new story each week. Savannah also asked Council to consider supporting the bid in their packets (to be read later) for repairing the Library roof – especially now since the public is starting to get out and meet in person and the Library Meeting Room is a great asset for everyone. #### Opportunities for citizens to speak to the Council:

C. P. Pierson 1131 Oak Street referenced the growth at the Parks and Recreation Program Tournaments and would like to bring people to town where they would spend money at our local businesses. He would like to see the Victory Project move forward. He advised more reinvestments would be made if people had a place to stay in town (hotel/ lodging) and would like for Council to consider how this could be done.

Chris Nelson 8775 Co. Rd. 73 gave Council paperwork and addressed Council about the proposed State Prison to be built in Brierfield. He attended other city/ town water board

meetings and advised he and volunteers knocked on 200 +/- doors to inform constituents about the proposed prison and this is also in packets provided to Council.

Council Member Mitchell called on IMPACT Director, Sarah Hogan. Sarah called on Olivia Gilbert, Junior Mayor, Montevallo Junior City Council (MJCC). Olivia reported the MJCC had gained two new members, Super Youth Saturday is ongoing. MJCC is excited to be participating in the Little Free Library Project, and held a Drive-In movie. She reminded Council the program is seeking applications from students from the eighth grade and up for membership. The membership application is on the website and social media.

Sarah Hogan, Director of IMPACT Montevallo reported the POP the SUMMER event was well supported and thanked the volunteers that participated, especially the Montevallo Police Department. She reported Camp Journey is a free Summer Camp and will be held at Montevallo High School 21<sup>st</sup> – June 25<sup>th</sup> and is available to students going into 6<sup>th</sup> grade. Camp Journey is a partnership between the Shelby County Sheriff's Office, Calera Police Department, Montevallo Police Department, Shelby County Schools, and COMPACT 2020.

Council Member Mitchell reported graduation for Montevallo High School students was tonight at 6:30 p.m. The Boys & Girls Club Summer Program will be starting next week, she discussed ART WALK as a Summer project and would like to see the Library take the lead on reaching out to research for 2022. The American Village will be open Monday, May 31<sup>st</sup> for Memorial Day, from 10 a.m. to 2 p.m. The National Veterans Shrine and Register of Honor and the Colonial Chapel will be open. All other buildings will remain closed. There will be a service in the Colonial Chapel at 10:30, 11:30, 12:30 and 1:30 to honor America's fallen. Admission is free.

Council Member Swords called on Adele Nelson for the Chamber Report. Adele reported the 2021 Small Business of the Year Program will be Wednesday, June 3<sup>rd</sup>. The Mary Lou Williams Scholarship was awarded to Montevallo High School graduate Morgan Honeycutt and a picture would be taken at graduation tonight. Adele asked Council to waive the vendor fees for the 2021 Montevallo Farmers' Market. Council Member Dukes asked Adele if she could give guidance to the businesses on Hwy. 25 because they see what Montevallo Main Street has done and need help. See Appendix 5.

Council Member Swords called on Courtney Bennett, Executive Director Main Street Montevallo. Courtney reported Friday Nights at the Cove will continue on May 28<sup>th</sup> at Owl's Cove featuring DRUM the Program, music starts at 6:30 p.m. and will be interactive drumming and dancing. Courtney created a flyer for University of Montevallo students that provides information on finding goods, supplies, restaurants, and other items. She reported the Façade Grant Program is available through May 31<sup>st</sup> and would like any business that is interested to apply. She reported the City of Columbia hired Brittany Davis as their Main Street Director and she and Jackie Batson, Calera Main Street Director look forward to collaborating with her. She

reported Shelby County is the only county in Alabama to have three cities with the Main Street Designation and thanked the City, Council, Main Street Members, and volunteers for their continued support. See Appendix 6.

Councilwoman Swords advised the Finance Meeting will be held Wednesday May 26th, 2021 at 5:30 p.m. in Council Chambers.



#### MEMORANDUM OF AGREEMENT

WITNESS THIS Memorandum of Agreement (MOA) entering into this <u>20</u> day of May 2021, by and between the Shelby County Board of Education (BOE) and the City of Montevallo, Alabama (CITY), and

WHEREAS, the City has requested that the BOE consider allowing the City to construct a storm shelter on school property owned by the BOE behind the home-side bleachers at the football stadium in Montevallo, and

WHEREAS, The BOE is agreeable to allowing the City to use a small portion of BOE property for this purpose.

NOW, THEREFORE, the BOE, acting by and through its Superintendent of Education, with BOE approval and City agree as follows:

- 1. The BOE will permit the City to construct an emergency storm shelter on school property in the City of Montevallo for the purpose of providing refuge to community residents and/or school personnel during inclement weather conditions.
  - 2. The dimensions of said storm shelter will be approximately 30 feet wide by 70 feet long.
- 3. The location of the shelter will be adjacent to, or in the very near vicinity of the City of Montevallo Fire Station #1 building, located at 1105 Ashville Road, Montevallo, Alabama on a specific site which will be located and staked out by City and will be subject to approval by BOE or its authorized staff and representatives.
- 4. The City will be responsible for the design and construction of said storm shelter, including but not being limited to, the concrete slab as well as all electrical and sewer connections and other improvements appurtenant thereto.

- 5. The City will be responsible for maintaining the facility in good condition after construction is completed, and will keep and maintain the grounds immediately adjacent thereto in a clean and safe condition; City will also be responsible for maintaining public order during the use thereof.
- 6. The City will keep the structure locked and secure except during periods of inclement weather but will supply to school officials keys to the building for emergency use by school personnel.
- 7. The term of this Agreement shall be for five (5) years from the dates hereof and shall be subject to renewal for successive five (5) year terms with the mutual written consent of both parties.
