Montevallo City Council Work Session
June 28, 2021
5:30 p.m. at City Hall

Mayor Rusty Nix, Council Member Lelia Mitchell, Council Member Sonya Swords, Council Member Martha Eisenberg, were in attendance. Council Member David King, Council Member Kenneth Dukes, Absent. Quorum present.

Work Session called to order at 5:30 p.m. by Mayor Rusty Nix.

Discussion on Resolution 06142021-324 of the City of Montevallo to allow Mayor Nix to enter into negotiation with City Bowls, LLC, and Wasabi Juan's LLC for the purpose of a lease agreement for the Victory Building.

Discussion on AT&T request for use of Public Right of Way at 600 Island and Shelby Street for the purpose of installing a fiber optic cabinet for highspeed Internet service for the area.

Discussion of Officer Mike Wilder's request to proceed with a Weed Abatement at 110 Samford Street, two certified letters have been received by property owner, to move forward City Council would need to vote on property as "Public Nuisance" and once Council approved he would send another notice. The owner will have 30 days to comply. After the 30 days a Public Hearing will be held to declare the property a Public Nuisance and proceed with weed abatement and cleanup. Officer Wilder recommends August 9th, 2021, for the hearing date.

Chief Littleton presented the Police Department Monthly Report. Chief Littleton reported there was a Total of 16 Traffic Accidents, 72 Traffic Citations, 24 Total Arrests, 2 Thefts. Chief Littleton reported he and officer Holloway participated in Camp Journey last week. Chief Littleton gave the Code Enforcement Report which had a Total of 1 Case that was reported, 4 properties that had overgrown grass and weeds, 1 Trash and/or Debris, 2 Inoperable Vehicles, no unsafe structures, 1 Miscellaneous, 1 Closed Case, 6 Continuances for a Total of 7 Cases, and a Total Number of Cases for the Year of 67. See Appendix 1.

City Clerk Gilbert read Chief Davis's Fire Department Monthly Report, with a total of 57 Total Calls, 42 EMS Calls, 2 Lift Assists, 4 Structure Fire, 1 Brush Fire, 1 Electrical Fires, 1 Vehicle Fire, 1 Fire Alarms, 5 MVC, Total of 57 Calls for the first half of June. He reported the Fire Prevention Division had a Total of 27 Fire Inspections and Reinspections. See Appendix 2.

Mayor Nix called on Kirk Hamby Public Works Director to give his report. Mr. Hamby asked if he could present his report to Council after the letter from Centreville Mayor Mike Coakley had been read.

Mayor Nix called on Olivia Barone, Sustainability Coordinator. She reported the ALDOT Permit requested in February was approved and 4 new LED lights have been installed on Hwy. 119 from City Hall to Hwy. 25. She reported they are aware of the light flickering at Quarles Street and Salem Road. She reported the ADECA/SouthFace Energy Audits were finished on June 18th, 2021 and we have been awarded project funding to do 3rd party audits on: Library, Fire Station 2, and Recycling Center; Estimated \$30,000 engineer labor, and thanked the Department Heads (Savannah Kitchens, Chief Davis, and Chief Littleton) that allowed them to come into their space. The Sustainability's website has been updated with current programs. She reported there are two Grants coming up in July: 2021 ADECA State Energy Program and Alabama Clean Fuels Grant. See Appendix 3.

Council Member Eisenberg called on Shane Baugh, Parks and Recreation. Shane reported the Youth Team will be at the World Series on July 8th, 2021. Football and Cheerleading registration is next week. He reported he is still accepting bids for the bridge in Orr Park and has only received 1 bid at this time.

Council Member Mitchell called on Savannah Kitchens, Library Director for the Library Report. Savannah reported the roofing repairs have been completed and so far there are no leaks. Summer Reading Program has circulated over 86 boxes since June 3rd 2021. She reported Birdwatch Bingo is ongoing and Dial-A-Story is updated each week. DRUM the Program will be at the Library July 8th in the Library Garden and July 15th is slated for Outdoor Movie Night. See Appendix 4.

Council Member Mitchell made a motion to approve the Minutes as corrected, second Council Member Eisenberg, All Ayes, Motion passed.

Recognitions / Awards: Mayor Nix read a "Thank you" letter from Mayor Mike Oakley with the City of Centreville, for the City of Montevallo's help during their tornado recovery effort loaning

equipment and manpower. He specifically recognized the hard work by Byron O'Neal during the tornado recovery in the letter. See Appendix 5.

Reports resumed and Mayor Nix called on Kirk Hamby Public Works Department. Kirk continued his report by highlighting Byron O'Neal and his work to assist the City of Centreville and that Byron celebrates 20 years employment with the City this month. Kirk advised it would boost morale if we were to highlight an Employee of the Month at a date in the future. Kirk reported he spoke with Mayor Oakley of Centreville and advised the Mayor was ecstatic about the amount of work Byron completed. He also thanked Chief Davis for providing a truck to transport a Bobcat Loader to assist with clean up.

Mayor Nix recognized Freda Shivers for 12 years of service and leadership to the Boys and Girls Club of Montevallo. Mayor Nix presented a Proclamation to Freda Shivers at the Boys and Girls Club last week at her retirement celebration. See Appendix 6.

Opportunities for citizens to speak to the Council: None

Reports resumed and Council Member Mitchell called on Olivia Gilbert, Junior Mayor, Montevallo Junior City Council (MJCC). Morgan Gray, Impact Montevallo's Youth Coordinator advised Council she will be reporting on behalf of Junior Mayor, Olivia Gilbert. She reported the MJCC plans to submit a revision to their Bylaws in order to update language that meets criteria for today's virtual world to the Council for consideration in August. The MJCC is currently on vacation. The MJCC has 3 new members. A retreat will be planned in early August for all MJCC members to elect officers, review bylaws, procedures, and learn skills that will assist them in representing the City. Impact is partnering with the MJCC on a Mural Camp to be held July 12th with a theme of Bulldog Pride & Inclusion.

Morgan reported for Sarah Hogan, Executive Director, Impact Montevallo and reported about Camp Journey. She thanked the Mayor and Montevallo Police Department for their involvement and Officer Holloway for coordinating the camp in partnership with the Shelby County Sheriff's Office and all the officers that participated in the camp: Chief Littleton, Investigator Gray, Officer Wilhite and others. See Appendix 7.

Council Member Mitchell reported the American Village will be open to the public for Red, White and Blue Days every Monday – Friday, 10:00 a.m. – 4:00 p.m. June 14th – July 30th and admission is \$5 per person. The American Village announced it will offer a full year of school programs beginning October 1^{st.}. Council Member Mitchell reported the American Village will not have their July 4th Independence Day Celebration.

Council Member Mitchell reported the University of Montevallo is holding Ebenezer's Explorers Day Camp July 12th – July 16th for rising sixth through eighth graders, the Cashier's Office has changed names to the Office of Student Accounts, Summer One final exams will be July 2nd and Summer two will begin on July 12th.

Council Member Mitchell reported on the Boys and Girls Club, if you see Freda Shivers tell her thank you for her service, Summer Camp is doing well, and they still need donations if you would like to help call 205-665-4466.

Council Member Swords called on Courtney Bennett, Executive Director Main Street Montevallo. Courtney reported July 30th will be the final Friday Nights at the Cove. Facade Grants have been awarded to all 10 applicants. On June 17th, the City of Montevallo was proud to be home to the first "Greening Your Community Workshop" featuring Ed McMahon as the keynote speaker. Approximately 40 attendees toured Shoal Creek Park and 70 attendees from across Alabama came to learn the importance of green space in their communities. Attendees also explored the Mainstreet District downtown. She also reported the Pendleton Hydrant Trail brochure has been printed and posters featuring all of the hydrants are being framed and will be installed at City Hall, Water and Fire Departments. Appendix 8.

Council Member Swords spoke on behalf of Adele Nelson, Montevallo Chamber of Commerce, and reported the Farmers Market is being held each Monday from 3:00 p.m. – 6:00 p.m. with 18 vendors participating. The market will continue through August with the exception of July 5th observance of Independence Day Holiday.

Council Member Swords reported the Finance Report is in Council packets. See Appendix 9.

- Designs should fill the entire design area. Do not leave white space unless it is intentional.
- Make your artwork <u>vertical</u> and keep in mind that some cropping near the edges of the banner may occur in the printing and installation process. When creating your designs keep your most important elements centered on the template!
- Work should be original and not include any copyright images (ie. branded cartoon characters)
 or names.
- Create a design with minimal or no text (if you include text avoid proper names like businesses, places, people).
- Artists should be between the ages of 5 18.



7 June 2021: Second Notice - I sent the second Certified Letter to Samuel Mburu. I advised him that I again inspected the property and found that no improvements have been made. I gave Mr. Mburu fifteen (15) days to correct the problem, due on 22 June 2021. In this letter I advised Mr. Mburu, if the improvements have not been made by 22 June 2021, I would present the case to the city council to rule the property a "Public Nuisance". I explained to Mr. Mburu the city council could decide to mow the grass and clean up the trash and debris, or they could hire someone to do the work. I also advised, the cost of this work could be placed as a lean on the property.

22 June 2021: I performed a third (3rd) inspection of the property. There has been no attempt to make contact with me by Mr. Mburu. The condition of the property has worsened, the overgrown grass and weeds have taken over. Trash and debris is still scattered over the yard. I took photos of the property:

Case Synopsis

The purpose of this presentation:

Sec. 14-61. The City Council shall determine whether the weeds, surplus grass, or other unwanted vegetation growing upon a street, sidewalk, or private property are a "Public Nuisance" and shall declare the same by resolution.

- Once the resolution is made, a hearing date will be presented to the City Council for approval. The hearing date will be set on/or after 30 days from the resolution. A "Notice of the Council's Decision" will be sent to the property owner by Certified Mail.
- A Notice shall be given by publication in a newspaper normally read by all segments of the population, published in the county once a week for two consecutive weeks.
- At least seven (7) days prior to the "Hearing" date, the code enforcement officer shall erect two signs upon the property, containing the date of the "Hearing".
- During the thirty (30) day time period, the code enforcement officer shall make contact with contractors who perform this type of work. These contractors will be presented to the council at the proper time.
- Sec. 14-64. At the hearing the city council shall hear and consider all objections, evidence and protests regarding the proposed removal of weeds. The city council may continue the hearing from time to time. Upon the conclusion of the hearing, the council, by resolution, shall decide whether a public nuisance exists, and if so, shall order it to be removed or abated with respect to any property or part thereof described.

"NOTE" - Any property owner shall have the right to have such weeds, surplus grass, or other unwanted vegetation removed at his own expense, providing the removal is done prior to the commencing of the work by the city and/or it's contractor.
