

Chief Bill Reid updated the council on activities at the Fire Department. He said March was busy with 109 calls. The box has been mounted to the new chassis for Rescue 21. They are working on attaching the light package. It should be ready in a month. The SCBA grant bid looks good. NAFECO was the sole bidder at \$141,072 for 41 air packs. The Public Health & safety Committee recommends approving the bid. In addition, the Chief informed the council that they discussed a proposal with the Committee to use \$90,000 of the money left to the Fire Department by Ms. Mahler to make improvements to Station #1. He said their volunteers would do the majority of the work, netting us around \$250,000 worth of improvements for that \$90,000 investment.

Mayor Cost said the remaining \$10,000 would be used to purchase AEDs for several locations around town. The AEDs would be phased in, with the \$10,000 being used for the first phase. The Committee also recommended these expenditures.

Council Member Walker stressed that the money for these items would come from the Mahler bequest.

The City Clerk mentioned that we still do not have clear title to Station #1.

Kirk Hamby, Director of Public Works, informed the council that the Big Event was a he success. He said he could tell because there were a lot more brush piles set out around town after that weekend. As a result, his crews hare backlogged. Grass in the right-of-ways is coming up fast. He also mentioned again what a big help the Saturday litter clean-ups were. He said he hopes that will continue.

Mayor Cost said she hopes ValloPals will pick up where the Bicentennial Committee left off.

Mr. Hamby also noted that his crews continue to battle household items left along the roadside.

Council member Nix reported that the Easter Egg Hunt is Saturday at 10 AM at Orr Park. He encouraged everyone to attend, noting it is a lot of fun.

Mr. Hamby reported that we had travel ball tournaments at three of our fields at Stephens Park last weekend. The MHS baseball team made the playoffs. Girls' softball has another month to go. He also reminded everyone that Farm Day is Friday at MHS, with the parade on Saturday.



Council Member Walker informed the council that the Finance Committee discussed the issue regarding fees charged by the Humane Society. He said they recommend pursuing a flat rate agreement with the shelter so we know what our cost will be. He said overall, the city's financial condition remains solid. He also reminded everyone that the Chamber Golf Tournament will be held toward the end of the month.

The Mayor then reviewed the remaining Agenda items with the council.

Council Member Nix detailed the Park & Recreation Committee's recommendations regarding the Boys & Girls Club lease.

The Montevallo Boys & Girls Club has expressed an interest in fully leasing the Park & Recreation Building. As you know, the city currently leases the facility to the Boys & Girls Club five days a week. They "pay" us \$1 a year in "rent" and cover 40% of the total utility costs each month. However, we reserve weekends for the possibility of community rentals. We rent the building on weekends at a rate of \$150 per day and we stay pretty much booked year-round – generating around \$6,000 a year in gross revenue. That revenue, however, is offset by the 60% in utility costs we pay, as well as cleaning fees of around \$434 per month and \$25 in pest control services, plus other maintenance costs. As such, keeping the building available for weekend rentals actually costs us \$9,115 or more each year.

Allowing the Boys & Girls Club to lease the building fulltime would allow them to expand youth activities and other programming over the weekend. Importantly, turning the full use of the facility over to the Club would also eliminate our operational loss of approximately \$9,115 per year. Therefore, the Recreation, Preservation and Community Development Committee (Park & Rec) has recommended it is the best interest of the city to extend and expand our existing lease with the Boys & Girls Club to allow them full and autonomous use of the building. Of course, we would require them to accommodate both the city and county for elections, as well as partnering with us to host Arbor Day each year. We would also maintain a shared right to utilize the parking lot.

With all this in mind, we propose leasing the facility to the Boys & Girls Club at a rate of \$1 per year for a period of 10 Years. Said lease would include a termination clause giving either party the unilateral right to cancel said agreement with a 120 day written notice. The Boys & Girls Club may make improvements to the facility as approved in writing by the council. If the council exercises its right to terminate the contract early, the city would agree to refund the Boys & Girls Club the depreciated cost of any improvements made by the Club which were authorized by the council.

As mentioned before, this would be a “net” lease with the Club being responsible for its own utilities, maintenance and insurance. Naturally, we would also keep the building on our insurance to cover the city in the event of a major loss. However, we will not be obligated to make any maintenance or repairs to the facility.

We, therefore, request that the council authorize the mayor to enter into a new lease agreement / memorandum of understanding (MOU) between the City of Montevallo and the Montevallo Boys & Girls Club based on the aforementioned terms and conditions.

Mayor Cost noted that Tom Walker at American Village has recommended the reappointment of Richard Anderson to that board.

Council Member Bunt asked if there was a way to identify some temporary handicapped parking spaces between Shelby and Middle Streets during construction. She said she heard concerns from the hair salon that their elderly clients had trouble finding a convenient place to park at the Hair Station and Smitherman’s.

Mayor Cost mentioned that we had originally discussed using a van to shuttle people around town during construction. However, this has not seemed to be needed, thus far. She said she will talk to the contractor about adding handicapped spaces.

Mayor Cost reminded everyone that the site plan was recommended by the Planning Commission as detailed in the following:

Recommendation to the Montevallo City Council

From the Planning and Zoning Board

April 10, 2017

On Thursday, April 6, 2017 the Planning and Zoning Board reviewed the proposed site plan for a Taco Bell restaurant to be located at 915 & 925 Main Street. Based on evidence and testimony presented to the Board, a recommendation to approve the proposed site plan with the condition that the applicant continue to revise the color scheme and building materials to include red/brown brick, colonial buff mortar with the original bronze color on the upper half of the building and coordinating color scheme overall, as requested by the Design Review Committee. It would be appropriate for the Council to allow the Mayor to make the final determination regarding color scheme and building material.

Council Member Bunt asked what the main sign will look like. Mr. Gray explained that the only signage will be that identified on the building itself. He said they have tried to keep with the character of our historic downtown.

Council Member Nix asked about the brick wall. Mr. Gray explained that, as suggested by the city's guidelines, their intent was to maintain the building site-line and block the view of their on-site parking as much as practicable.

There being no other questions or comments, the hearing was closed at 6:04 pm.

Whereas, Billy and Elizabeth "Beth" Rockco married in 1952; and

Whereas, Mr. Rockco served in the US Army and Alabama National Guard with honor and distinction from 1954 to 1964; and

Whereas, Mr. Rockco moved to Montevallo from Citronelle in 1962; and

Whereas, Mr. Rockco graduated from John A. Gupton Jones School of Mortuary Science at Vanderbilt University Class of 1966; and

Whereas, the Rockcos took over the former Hoffman Funeral Home in 1965 after the passing of his father-in-law, Gordon Hoffman; and

Whereas, Mr. Rockco and his wife built the present-day funeral home in 1968 as Hoffman-Rockco Funeral Home. In 1980, name changed to Rockco Funeral Home after death of Pauline Hoffman. The Rockcos also purchased a funeral home in Centreville from Jack Lee and Sons in September 1978; and

Whereas, the Rockcos also ran the local ambulance service from 1968 to 1986, serving Montevallo, Calera and surrounding communities; and

Whereas, Mr. Rockco served as Shelby County Deputy Coroner for several years; and

Whereas, Mr. Rockco served on the Shelby Hospital Board of Directors and served as chairman from 1971-1973. His portrait hangs on the first floor hall of directors; and

Whereas, Mr. Rockco served on the Alabama Board of Funeral Services from 1985 to 1987 and also served as its chairman; and

Whereas, even though Mr. Rockco retired in 1998 due to health issues, he remained actively involved in the Montevallo community and a faithful, active member of Wilton Baptist Church up until his death on August 18, 2016.

WHEREAS: Strong family relationships constitute the foundation of our community; and

WHEREAS: Alienating behaviors are frequently seen in high-conflict divorces, separations and asymmetrical custody arrangements but can occur in intact marriages; and

WHEREAS: Parental Alienation is a term used to describe any number of behaviors and attitudes on the part of one parent, both parents or third party designed to interfere, damage or destroy the relationship a child has with their other parent. It's a form of abuse that causes emotional trauma to children; and

WHEREAS: Parental Alienation deprives children of their right to freely love and be loved by both parents, their extended families and robs children of their sense of security; and

WHEREAS, we encourage all Alabamians to visit paawareness.com for information on raising awareness to stop Parental Alienation, and we call on community and state leaders to support shared parenting because of its benefits for children.

WHEREAS: The recently published Diagnostic and Statistical Manual of Mental Disorders (DSM-5) made several references to the dysfunctional family dynamic of alienation to be a form of psychological child abuse; and

WHEREAS: Approximately 40,000 children in the State of Alabama were subjected to child custody determinations in 2014; and

New Business:

TACALA (Taco Bell) Site Plan Approval – As recommended by the Planning Commission, Mayor Cost said she would work with the Main Street Design Committee to approve the final design choices for Taco Bell. Council Member Nix made a motion to approve Site Plan and authorize the Mayor to give the final approval of the design choices. Council Member Nix seconded. ALL AYES . . . MOTION APPROVED.

Mike Gray thanked the council and said they will coordinate their efforts with the Streetscape contractors. Once they begin work, it should take around 11 weeks to complete the project.

USDA Presentation, Robert Macon – Robert Macon with USDA discussed a variety of programs his agency offers which could benefit the city and its citizens. Anyone interested in learning specifics about these programs can contact him at Robert.macon@al.usda.gov.

UM Class Presentation – Dr. Caplow - Tori Sanders presented her class' proposal to the council. They recommended using funds from the city's Sanitation Account to purchase new trash cans for Main Street and to re-paint six of our existing cans green in order to use them for collecting recyclables. She said the entire project should cost the city around \$3,000. She asked the council to make a decision quickly because her class ends soon and they want to help to paint the cans.

Mayor Cost said this is a proposal worthy of consideration.

Council Member Nix asked who would pick up the recycling. Mayor Cost explained that our crews would pick up the recycling along with the trash from the other cans like we do now. We'd collect the recycling bags and turn them over to Waste Pro for processing.

Council Member Peterson made a motion to approve the expenditure of up to \$3,000 from the city's Sanitation Reserve Account to carry out this project. Council Member Bunt seconded. ALL AYES . . . MOTION APPROVED.

Boys & Girls Club Lease –

Council Member Nix asked if they plan to continue to rent the facility to the public when they are not using it.

Freda Shivers explained that other clubs do not rent out their facilities, so she doubted they would approve the rental of this one. However, she said they would honor any rentals currently on the books. However, she said she would do her best to see if that can be done.

Mayor Cost pointed out that the facility would still be available to the city for events such as Arbor Day and Elections.

Council Member Nix made a motion to authorize the Mayor to enter into an agreement with the Boys & Girls Club upon the terms and conditions previously discussed. Council Member Goldsmith seconded. ALL AYES . . . MOTION APPROVED.

Memorandum of Agreement

**By and between the
City of Montevallo and Montevallo Boys & Girls Club**

The City of Montevallo hereby agrees to allow the Montevallo Boys & Girls Club (BGC) to lease the city's Recreation Center for its organizational activities for \$1.00 per year for a period of 10 years; and

The City hereby declares that the Recreation Center is "surplus" and is not needed for public or municipal purposes, except as further defined herein; and

The City finds that the agreement for less than adequate consideration serves a public purpose and promotes the general health, safety, morals, and welfare of the public; and

The BGC has the flexibility to rent out the building on weekends but said lease would be between the BGC and renter; and

The BGC hereby agrees to indemnify and defend the City in the event of an accident or injury; and

It is understood and agreed that the BGC is not the City's "agent, servant or employee" and that the City does not reserve any right to control the use of the facilities when it is being rented to a third party; and

The BGC is responsible for all utilities; and

The BGC is responsible for regular maintenance and housekeeping. Larger issues such as roof replacements or significant plumbing or electrical issues will be considered on a case-by-case basis; and

Any improvements to building that BGC proposes would need council approval; and

The City reserves the rights to utilize space for Arbor Day, as well as Municipal and County Elections; and

Main parking lot is to remain available for public parking; and

Senior center parking lot would be designated for senior center business only M-F 8:00 a.m. – 6:00 p.m.; and

The BGC agrees to maintain a minimum \$2 million dollar liability insurance policy on the property naming the City of Montevallo as additional insured; and

Either party may terminate this agreement with 120 days written notice; and

If the City exercises its right to early termination, the city agrees to reimburse the BGC for the undepreciated portion of any authorized improvements made by the BGC to the facility; and

Upon termination, the BGC agrees to leave the premises in as good or better condition than it was delivered to them.
